not experiencing an overdose. Narcan distribution programs have been shown to decrease opioid-related overdose fatalities nationwide.

The medication was recently approved for over-the-counter sales by the FDA earlier this year.

ROSC began to partner with the Hour House in Charleston in January to provide DOPP sites across eight counties, including Coles, Clark, Cumberland, Douglas, Edgar, Effingham, Moultrie, and Shelby Counties. Hour House Recovery Orientated System of Care (ROSC) Coordinators and Recovery Navigators will train, supply, and support Narcan distribution sites throughout the eight-county region. Expanding access to this harm reduction tool, the program aspires to prevent opioid-related overdose deaths in these communities.

Additionally, Hour House ROSC Council team members will provide Narcan and Narcan training to anyone who requests it by calling 217-348-8108. To access Narcan, stop by any one of the community distribution sites or call the number to obtain kits or educational resources free of charge.

Jackie Wells, director of the Camargo District Library, said, "I feel that library services are changing radically. We're still here with books and movies, we're trying to be more of a social hub, I guess, and we're trying to make things available."

Wells said she personally has known friends and people in her family that have struggled with addiction and believes the program is great for the community.

The Narcan provided at each site is found in discrete locations alongside extra informational pamphlets.

"The goal is to have more education for people and less-

en the stigma. We don't want people to feel bad coming in to get it. If you need it, you need it," said Wells.

Marsha Burgener, library director at the Atwood Hammond Library district, said, "We feel that there is a need in the community to have that available. (...) There have been drug-related deaths. There are probably parents or spouses that might know someone living in their home that might have a drug addiction and they want to have it on hand in their home if they have the misfortune of finding someone who is non-responsive," said Burgener.

The Atwood Hammond Library is also working together with Kirby Medical Center to provide classes regarding mental health. Burgener said they are also working together with Moultrie Douglas schools to provide help with mental health in classrooms.

"Anyone that needs any kind of help, we're here to offer them, programs, information, anything that can help anyone struggling with addiction or any mental health program," said Burgener.

Terri Haas, pastor at the Tuscola United Methodist Church, said, "Every single person has the potential to save a life when they have Narcan," said Haas.

The goal for Haas is to prevent as many deaths and overdoses as possible. Parish Nurse Chelsie Evans also teaches classes on how to administer Narcan. Haas said Evans is very good at explaining how the medication safely helps people.

The Douglas County Recovery Navigator Darlene Smith also offers education for recovery in an upcoming program in Camargo on June 21 at 11 a.m. in the Camargo Township District Library. She talks about

pathways to recovery with discussions about medication-assisted treatment, the Twelve Step Programs, and more. She can be reached at (217) 549-7481 for more information.
