contract. Chaplin said the contracts have stayed mostly the same with 4 percent increases to wages each year. The agreement should help the department keep competitive wages compared to agencies of the same size, according to Chaplin.
 The Board approved an agreement with Larson, Woodyard and Henson LLP for the County's budget analysis. The cost of the analysis is capped at \$6,500.
 The Board appointed Gary Luth and Bibby Appleby to the Opioid committee.
 Chase Robinson was approved for lawn care services on an as-needed basis at the County Courthouse, Annex and Jail.
 The Board adopted a new Employee Assistance Program (EAP) for one year. The program costs \$35 per person, per year. Board members Ed Carlton and Phillip Morris voted against the program
 According to Judi Pollock, the EAP offers services to employees and their entire family. The program, focusing on mental health will include counseling, with six sessions

per problem per year, one hour of financial consultation, one hour of legal consultation, and more online resources.
 A previous EAP, costing \$9 per month for each employee was underutilized. Employees were able to use it for telehealth consultations, which are now covered under employee's healthcare plans.
