lows telecommunications companies to occupy a right-of-way to install fiber optic cables. Because of this, the city tries its best to coordinate and work with the companies, whenever they do construction.

While the installation of the fiber optic can be frustrating to many residents, the long-term benefits can be great.

Fiber optic cable internet uses a glass or plastic filament "wire," about as thick as a human hair. Data travels through the filament as light, which connects to a home or business modem. This can allow internet speeds to be 20 times as fast as cable. Cable internet relies on copper wires, which heat up and weakens signals and causes interference.

However, fiber optic internet speed is dependent on a few factors. The fiber optics can be installed in three ways. To the home, the curb or the neighborhood. If installed to the home, residents experience the fastest internet possible through fiber optic. The other options rely on metal wiring at different lengths, which slows down the signal and gives residents the "not much better than cable" experience.

Fiber optic internet is not prone to "throttling" and can be more reliable since it can handle more users and more data at higher speeds. Fiber optic cable also doesn't rely on energized lines, so it's not as prone to outages as well.
