## Douglas County Board designates \$100,000 for RISE crisis line

The Douglas County Board designated \$100,000 in American Rescue Plan Act (ARPA) funds for RISE Behavioral Health and Wellness in Tuscola. The money will be used to fund RISE's 24-hour free crisis line.

In last month's meeting, the Board planned to remove the designation, as they hadn't received a project proposal from RISE for ARPA funds. After a discussion with RISE's director Lauren Christina, the Board tabled the decision.

Since then, RISE has met with the Douglas County budget and finance subcommittee regarding the project proposal for the Board.

Christina explained that the ARPA funds would help pay the wages of mental health workers operating the crisis line. RISE receives payments by charging insurance companies for mental health services for their clients.

Christina said the funding for the crisis line came from the state before July 2021, when the state began moving funds toward the 988 Suicide and Crisis Lifeline. The crisis line did not have a loss in service when it lost funding in 2021.

The RISE crisis line offers callers the chance to talk with a local mental health worker if they are experiencing a mental health crisis, whether that be an acute increase in symptoms or suicidal feelings.

"We thought it would be beneficial to keep it in-person," said Christine. "Clients like to call people they know."

RISE works with the sheriff's department to screen calls; caller's names and phone numbers are taken by the sheriff's department and then a RISE worker will call back within five minutes. If RISE determines that a caller needs immediate assistance, they can ask the Sheriff's department or emergency med-

ical services to send someone.

The 988 Suicide and Crisis Lifeline is similar to RISE's service but is more anonymous. Callers are directed to call centers across the country. The hotline also has the ability to send a mental health professional to the caller's location.

If you are experiencing a mental health crisis, you can call RISE's free 24-hour crisis line at 217-253-3511. You can also dial 988 to reach the Suicide and Crisis Lifeline.

In other news, the Board approved the administrative office of the Illinois Courts lease agreement at the Douglas County Annex. The office space will be leased for five years at \$2,400 yearly.

The Board approved resolution 23-R-4, which allows Douglas County Board members to attend Board meetings electronically. Board members will be able to attend via video, audio conference and other "contemporary interactive

communication" such as electronic chat, mail and instant messaging. Member's votes would be counted the same as if they are physically present.

Jim Higgins, former owner of the Tuscola "Do It Best" hardware store, was appointed to the Douglas County Board of Health.

The Board voted against resolution 23-R-5, the declaration of emergency due to COVID-19. The resolution has been voted on every month

since the start of the public health emergency.

Governor JB Pritzker announced Jan. 31 that the state's public health emergency will end on May 11, aligning with the federal government's decision to end the national public health emergency. Illinois aligned itself with the federal government to ensure resources for the state's response to the COVID-19 pandemic.

The Board reappointed the

insurance administrator liaison to Douglas County.

The Board approved the annual stipend for payment and reconciliation of payroll deducted insurance benefits of \$3,000 to staff.

The Board approved resolution 23-R-6, which authorizes the execution and amendment of the section 5311 grant agreement. The funds from the agreement will be used for the new Dial-A-Ride vehicle storage facility, which received \$1.1 million in grant funds by the Department of Transportation.

The Board approved the extension of local agency agreements for job R-95-326-15 and R-95-328-15 to March 2025. The agreements are for Cronus Chemicals Infrastructure improvements.

The Board approved the purchase of a copier for the supervisor of the assessments office, along with a maintenance contract of \$150 per month.
