Download the American Red Cross Blood Donor App, visit RedCrossBlood.org, call 1-800-RED CROSS (1-800-733-2767) or enable the Blood Donor Skill on any Alexa Echo device to make an appointment or for more information. All blood types are needed to ensure a reliable supply for patients. A blood donor card or driver's license or two other forms of identification are required at checkin. Individuals who are 17 years of age in most states (16 with parental consent where allowed by state law), weigh at least 110 pounds and are in generally good health may be eligible to donate blood. High school students and other donors 18 years of age and younger also have to meet certain height and weight requirements.

Amplify your impact – volunteer! Blood donor ambassadors help greet, check-in and thank blood donors to ensure they have a positive donation experience.

Arthur to receive ARPA funds for water tower repainting

The Douglas County Board meeting authorized the use of \$282,300 in American Rescue Plan Act funds (ARPA) for a joint water project with the Village of Arthur. The Board also agreed to an intergovernmental agreement between Douglas County and Arthur for the repair and maintenance of an elevated water tower. The expected cost for the project is approxi-

The interior and exterior surfaces of the water tower will be sandblasted and repainted. Currently, the tower has mold and mildew buildup, which is described as an unpleasant visual sight rather than posing any threat to the tower's structural integrity.

The Board also authorized \$110,000 in ARPA funds to purchase air packs and other protective gear for Arthur Fire and Ambulance. The Board agreed to an intragovernmental agreement for the purchase as well.

The budget did not include \$1,600 per n grant money left over for courting April 1.

Douglas County Clerk and Recorder Judi Pollock said the changes could have been done at the end of the fiscal year but chose to do it sooner.

The Board approved the agreement renewal between Douglas County and road commissioners for the maintenance of county roads at the contract price of \$1,600 per mile for one year starting April 1

The Board also heard from Cultivate Power regarding a potential solar farm near Arcola. According to the company's website, it is a distributed solar and storage platform. Their focus is cultivating land into distributable renewable energy projects and ensuring that the projects benefit local communities.

mately \$315,000. Arthur will fund the remaining cost of the project, \$32,700.

According to the ordinance, the water storage tower in Arthur is in need of repair and maintenance as the water tower was last painted in 1996, 26 years ago. The average life span of a water tower paint system is 20 years.

In other news, the Board authorized an amendment to the Douglas County fiscal year 2023 budget. The amendments include the correct salaries of the State's attorney, \$146,188; pubroom projects that were completed in the Circuit Clerk's #77 Court Improvements fund. The line was added to reflect the grant's expense of \$60,033.

The budget did not include newly created funds for storage documents. \$25,000 for the Recording Document Storage and \$10,000 for the Vital Records Document Storage.
