Illinois-based Consolidated employees volunteer nearly 1,000 hours in 2022; Company recognizes efforts during National Volunteer Week

This year, the 40th SOFF will take place on September 16, bringing the full day of games and fun which Special Olympics International calls the ‘biggest event of its kind in the world.’ Bethany Kusterman, a CCI employee and the 2023 SOFF Chairperson, knows firsthand how impactful SOFF is for athletes.

“As a parent of a Special Olympics athlete who attended her first SOFF last year, I know how much this event means to our athletes,” she said. “To have a day that celebrates the Athletes in a fun and relaxed environment is important and truly special to witness. SOFF would not be possible without the dedicated support of local companies, our students and our community volunteering for this rewarding event.”

To further support and recognize employee volunteers, Consolidated created the CCI Cares Program in 2022. Through CCI Cares, the company makes contributions of \$250 to local non-profits for each employee who volunteers



25 or more hours. During the program's first year, Consolidated contributed a combined total of \$10,500 to 42 organizations.
