church after it burned, and the owners had agreed in writing to give the city a deed to the property, Bequette said

They have not yet done that, he said, and an effort to reach their attorney failed. Bequette said he has filed a legal motion to have a judge grant the deed.

He said he's not worried about it because the owners

had agreed to give the city the lot. He said he's confident that a judge will grant the city's request.

The city also voted to revise the fire department roster to clarify that Alison Morenz will serve as an emergency medical technician and not a firefighter.

From Hoel's ongoing projects report:

**Building Improvements:** Footings were dug this week on the new fire station. Footings were begun a couple of weeks

ago on the street shed addition, but the engineer has revised the design to include some drilled piers due to the condition of the soils and fill encountered. This will likely result in a change order, but the cost will, hopefully, be minimized as the "spread" footings originally called for can be reduced in size, decreasing the amount of concrete required. Wohlman has indicated that construction would be in full swing following Labor Day, so we should see substantial

activity on both projects in the coming weeks. Finally, we met with the architect and mechanical engineering team at the Police Station this week and they will be preparing revised scope and budget estimates for your review.

**Downtown Alley Improvements:** Feutz continues work on the Downtown Alley Improvements. Most of the alley concrete behind the Community Building is complete, and they have begun tear-out of the

alley one block east. They will continue pouring the alleys and begin work on the plaza area and pedestrian path connecting to Sale Street.

**Water Improvement Projects:** DCEO has not yet issued the grant agreement for the Meadowview water main replacement project. We expect to receive that soon, and we will proceed to bid advertisement as soon as possible after receipt.

**Insurance Renewal:** Currently, I am working with two

potential insurance carriers who will provide proposals for our insurance coverage, in addition to the renewal proposal we will receive from our current carrier, IMLRMA. I have asked for proposals no later than the end of October, so that you all

can consider an award in early November. IMLRMA offers an early-pay discount which we will want to take advantage of in the event we elect to remain with them.
