Anderson Healthcare President/CEO Keith Page to retire in February 2024

Current COO Mike Marshall to assume the responsibilities of Anderson Healthcare president/CEO, with current Chief Nursing Officer Lisa Spencer moving into new position as Anderson Hospital president

Anderson Healthcare President and CEO Keith A. Page announced his future retirement and succession plan to the staff of Anderson Healthcare early last month.

Page is planning a February 2024 retirement which will then mark 28 years of leadership at Anderson Healthcare. "It has been an incredible privilege to serve as the President and CEO of Anderson Healthcare," said Page. "Together, we have achieved remarkable milestones, overcome challenges, and made a lasting impact on the lives of countless patients and their families. I am immensely proud of the progress we have made in advancing healthcare, fostering innovation, and providing exceptional care to our community."

Page began his career at Anderson Hospital in Maryville as chief operating officer in 1996 and became president

and chief executive officer in 2003. He has spearheaded many key projects over the years including the Warren Billhartz Cancer Center; an award-winning chest pain center and cardiac catheterization lab; private patient rooms; 24/7 SSM Cardinal Glennon pediatric staffing in Anderson's emergency room and OB unit; four Express Care facilities throughout local communities; the establishment of Anderson Healthcare; the addition of Community Hospital of Staunton to Anderson Healthcare; and the establishment of Anderson Medical Group.

Most recently, Page led the development of a 15-acre Anderson Healthcare Goshen Campus in Edwardsville. This location includes three facilities including the Anderson Surgery Center with Cardinal Glennon Specialty Clinic, the Anderson Rehabilitation Institute and a 50,000 square foot, multi-specialty medical building offering outpatient services as well as over 20 Anderson Medical Group providers.

"None of these accomplishments would have been possible without the unwavering dedication and commitment of our exceptional staff," expressed Page. "I am grateful for having been a part of such an extraordinary journey, transforming a small community hospital into a regional healthcare system."

As Page prepares to step down from his role in 2024, he is confident that the hospital is in capable hands as his transition has been carefully planned for several years. "Our leadership team, along with the entire staff, is well-equipped to navigate the ever-evolving landscape of healthcare and continue to deliver exceptional care to our patients," he said.

Page announced that upon his retirement, current Chief Operating Officer Mike Marshall will assume responsibilities of president/CEO of Anderson Healthcare. Current Chief Nursing Officer Lisa Spencer will take on a new position as president of Anderson Hospital. "Mike and Lisa have shown extraordinary leadership and knowledge of our organization over the years," said Page. "I have no doubt that under their leadership, we will continue to be a pillar of

Contegra constructs EnerVenue manufacturing gigafactory for **NASA-tech-based batteries**

One of two industrial buildings being built at Flint Development's I-64 Logistics Center will house a gigafactory for the next generation of efficient energy storage.

Contegra Construction Co. is targeting an end of summer completion for a 1.015 million-square-foot shell building where EnerVenue will manufacture batteries based on nickel-hydrogen technology originally developed for NASA. EnerVenue says its technology is ideally suited for grid-scale, commercial and residential applications. Contegra is also building a 478,000-square-foot distribution center for Flint Development at I-64 Logistics Center with an end of summer completion.

EnerVenue's Energy Storage Vessels were born from metal-hydrogen energy technology used by NASA beginning in the 1980s to support the Mars Rover, International Space Station and Hubble Telescope. It was further refined at Stanford University in 2017 where EnerVenue emerged through the university's business accelerator. Compared to traditional lithium-ion batteries, EnerVenue says its Energy Storage Vessels improve upon the limitations of today's solutions, offering a 30-year lifespan, robust temperature performance, greatly improved fire safety, while remaining almost completely recyclable. The company expects to begin production in 2024.

Located on 115 acres, the I-64 Logistics Center is designed to serve Louisville's growing industrial market. The one-millionsquare foot facility that will house EnerVenue's gigafactory is constructed of tilt-up concrete panels, topped by a TPO roof and will feature a 40-foot clearstory. The building will have five dock doors, four drive-in doors and host 300 trailer parking spaces.

The 478,000-square-foot distribution center has a 36-foot clearstory with flexible space for multiple tenants. It is served by 48 dock doors, four drive-in doors and 115 trailer parking spaces.
