NOTICE OF DELINQUENT PERSONAL PROPERTY TAXES LOCATED IN GRADY COUNTY, STATE OF OKLAHOMA

Notice is hereby given, pursuant to Title 68 O.S. Section 3102, that certain taxes on personal property have become delinquent for the year 2025, and if not paid within thirty (30) days from date of this publication, shall be placed on a personal property tax lien docket in the office of the county treasurer and the homestead exemption of such taxpayer shall be cancelled pursuant to Section 2892 of Title 68. Such liens are superior to all other liens, conveyances or encumbrances filed subsequent thereto, on real or personal property. The tax lien shall be a lien on all real and personal property of the taxpayer in the county for a period of 7 years, except as otherwise provided in subsection B of Section 3103 of Title 68. From and after the entry of the tax upon the tax lien docket, any person claiming any interest in any land or personal property can sue the county treasurer and board of county commissioners in the district court to determine the validity or priority of the lien.
