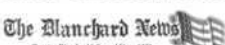

Terry Daniel moved to approve the proposal and service agreement provided by Johnson Controls in the amount of \$712.24 for fire sprinkler system components, Glen Murray seconded. Vote Aye: Murray, Lyles, Daniel. Motion carried.
