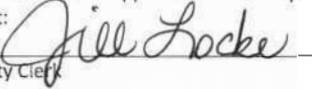
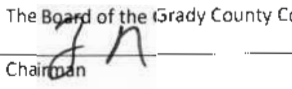
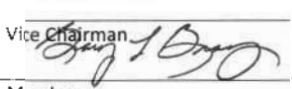

Mr. Sifers recommended meeting with City representatives to gather additional information and discuss the request further. The Commissioners agreed that the matter warranted additional review. They stated they would look into the request and consult with the auditors before making any decisions.

Jeff McClure, representing CMS Willowbrook, presented the bid tabulations for the new Emergency Management Storage Facility. He explained that, following discussions with Commissioner Bingham, several items would be removed from the project scope to reduce the overall cost. He further stated that the County will complete the interior finish work and paving, which will provide additional cost savings for the project.

Zachary Davis made a motion to approve the tabled bid for the Grady County Emergency Management Storage Facility Phase 2 OEM ARPA Grant, bid by Construction Manager Willowbrook, see bid for pricing. It was seconded by Ruth Bingham. AYE: Zachary Davis and Ruth Bingham. ABSTAIN: Doug Duke

Doug Duke made a motion to approve to utilize material(dirt) on adjoining private property, with land owner Danny Harris's permission, in order to replace tin horn that washed out from heavy rains on CR1590 off of CS2940. 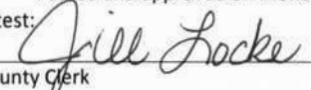
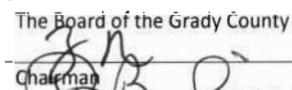
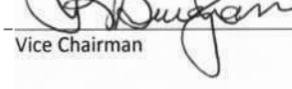
