To the residents of Wadena County:

Notice is hereby given as provided in Minnesota Statute 204B.33 that a General Election will be held on Tuesday, November 3, 2026 for the purpose of electing candidates for the offices listed below. The filing period for these offices is 8:00 a.m. Tuesday, May 19, 2026, to 5:00 p.m., Tuesday, June 2, 2026. The last day to withdraw is June 4, 2026 at 5:00 p.m. The place of filing is the Wadena County Auditor/Treasurer's Office, 415 Jefferson St S, Wadena, MN 56482.

Note: Filing offices will be closed Monday, May 25, 2026 in observance of Memorial Day.

The place of filing for federal offices is the Office of the Secretary of State, Veterans Services Building, 20 West 12th Street, St. Paul, MN 55155. The place of filing for state offices is with the Office of the Secretary of State or with the county auditor of the county in which the candidate resides. Candidates may file in person or by mail, if the filing is received during the filing period. Candidates who will be absent from the state during the filing period and meet the requirements of Minnesota Statutes section 204B.09, subdivision 1a, may arrange to file during the seven days immediately preceding the candidate's absence from the state.
