AN ORDINANCE TO LEVY AND ASSESS A MUNICIPAL TAX FOR CHILlicothe PUBLIC LIBRARY DISTRICT OF THE COUNTIES OF PEORIA AND MARSHALL, STATE OF ILLINOIS FOR THE FISCAL YEAR

BEGINNING JULY 1, 2026 AND ENDING JUNE 30, 2027

BE IT ORDAINED, that the Chillicothe Public Library District of the Counties of Peoria and Marshall and State of Illinois shall levy a tax of .02% of the value of all taxable property within said District, for building and maintenance purpose, subject to the right of the electors in said District to petition and require an election concerning the imposition of such tax, pursuant to 75 ILCS 16/35-5.

BE IT FURTHER ORDAINED, that within fifteen (15) days from the date of adoption of the ordinance, it shall be published in a newspaper of general circulation in the Chillicothe Public Library District.

This ordinance shall take effect immediately upon passage.

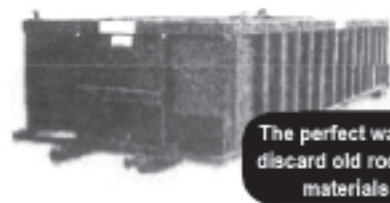
